### High Availability

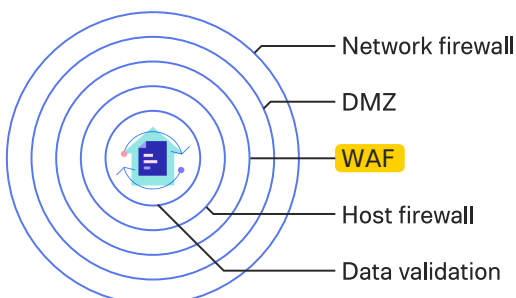

## Proactive and Layered Security

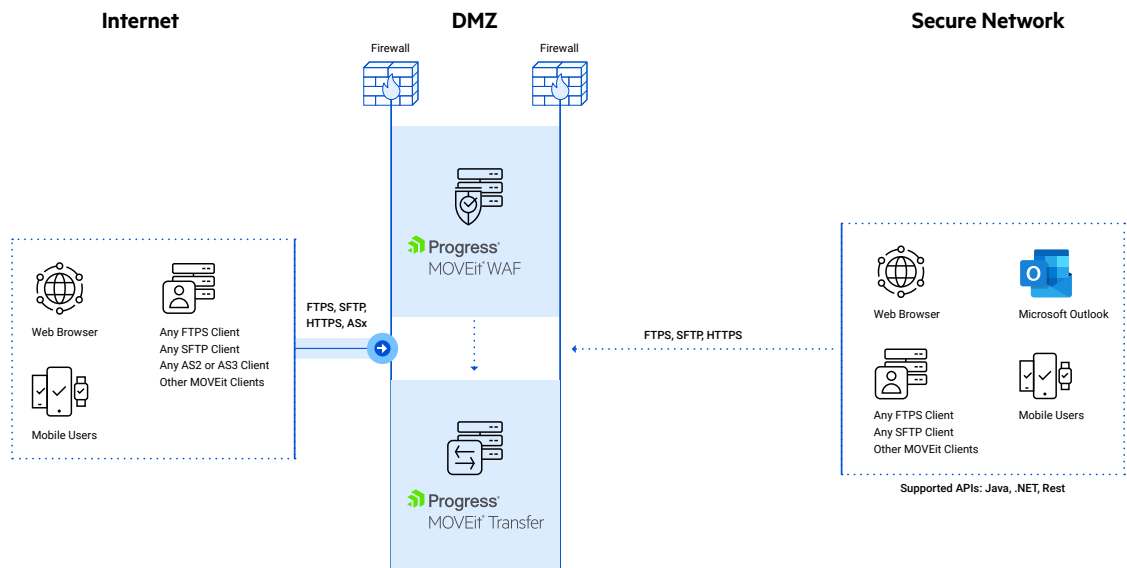
